

## MINUTES OF REGULAR COUNCIL MEETING AUGUST 26, 2025

The Shenandoah City Council met in regular session on August 26, 2025 at 6:00 P.M. in the Council Chambers of City Hall. Present were Mayor Roger McQueen and Councilmembers Rita Gibson, Jon E. Brantner, Kim Swank, Toni Graham and Richard Jones. Also present were City Clerk/Treasurer Karla Gray, City Administrator AJ Lyman and City Attorney Mahlon Sorensen.

Gibson moved; Brantner seconded approving the agenda. Passed unanimously.

Jones moved; Gibson seconded approving the consent agenda that includes: Minutes of the August 12, 2025 Regular Meeting; Ownership change for License # LE0001617 for Hy-Vee, Inc. DBA Hy-Vee located at 500 S. Fremont. Passed unanimously.

Gibson moved; Brantner seconded approving Abstract of Claims #2026-04 for \$136,814.85. Passed unanimously.

Swank moved; Gibson seconded approving the City Clerk to publish notice to solicit bids of City owned properties available for purchase by sealed bids [All bids due by 10:00 A.M. on September 19, 2025]. Passed unanimously.

Jones moved; Graham seconded approving setting City Wide Fall Clean-up date [October 18, 2025 from 8:00 A.M. to 3:00 P.M.]. Passed unanimously.

Gibson moved; Brantner seconded approving the purchase of a John Deere 4066R Compact Utility Tractor and a Trimax Snake [S-3-320] mower from Van-Wall Equipment, Inc. for the Golf Course [Purchase Price - \$89,156.70; 5-year Finance Price - \$104,179.60]. Passed unanimously.

Gibson moved; Brantner seconded approving the purchase of a Greensmaster TriFlex Hybrid 3320 mower from Midwest Turf & Irrigation [10% upon delivery and 5 annual payments starting July 2026] [Purchase Price - \$58,973.01; 5-year Finance Price with down payment of \$5,900.00 payable on or before October 1, 2025 - \$64,926.55]. Passed unanimously.

Jones moved; Gibson seconded approving Public Event Application for Santa's Workshop on November 29, 2025 for a lighted Christmas parade [Street closures-Sheridan Ave. from Willow St. to Railroad St.]. Passed unanimously.

Gibson moved; Jones seconded approving Street Closure request for Shenandoah Community School District on October 3, 2025 for the Homecoming Parade [Street closure of W. Sheridan between Railroad St. to Sycamore St.; Railroad St. between W. Sheridan and W. Valley Ave.; W. Lowell between Railroad St. and Elm St.] Passed unanimously.

Citizens Opportunity to Address the Council—Jeff Capps who resides at 1211 W Lowell stated his concerns of Social media comments on the water situation. Loretta Smith who resides at 403 Sycamore spoke on behalf of her brother's [Jeff Braman] residence located at 813 South Ave. Smith stated that her brother is in the process to demo the structure.

Council/Committee Reports—Sorensen gave an update on 102 W Sheridan-657A action. Realtor stated that the Seller has an offer on the property. Sorensen also stated that the property located at 104 W Sheridan, contract to purchase has defaulted. The property will be back in the deed holder's name soon. Sorensen will have the proposed buyer [102 W. Sheridan] and owner [813 South Ave.] at the September 9<sup>th</sup> Council meeting to present their plans. Councilmember Brantner gave an update on the Shenandoah Public Library.

There being no further business, Jones moved, Gibson seconded to adjourn the meeting. The Mayor therefore declared the meeting adjourned at 6:29 P.M. and to reconvene at the next regular council meeting on September 9, 2025, at 6:00 P.M.
